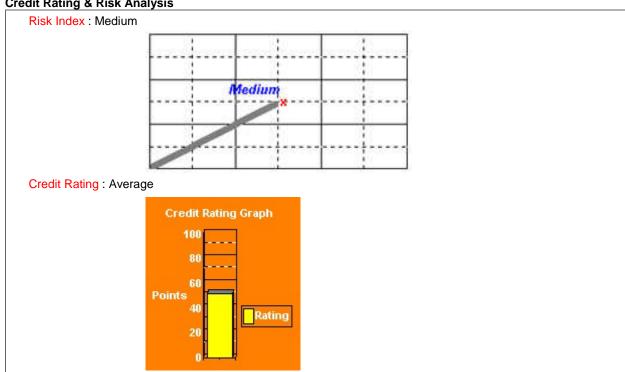

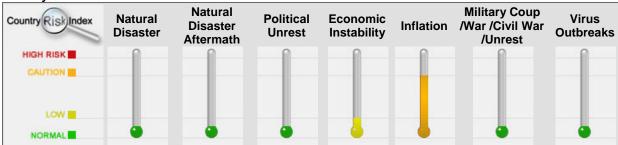

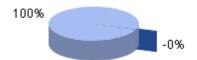

II. CONTACT COMPANY FOR SITE VISIT

During the course of the investigation, point of contact was Ms. Lucila SAMPLE (International Relationships and Translator; secretary@SAMPLE.com.ar). Email communication was always prompt and friendly.

III. CONDUCT A SITE VISIT

Date: May 30th, 2016

<u>Name/s and title/s</u>: Antonio Victorio SAMPLE (proprietor); Lucila SAMPLE (International Relationships and Translator).

Though both the above individuals were present at the interview, answers to the questions were given by Mr. SAMPLE.

<u>Location of Interview</u>: On-site at SAMPLE TECH ("Candidate")'s facility at the following address: SAMPLE 3343, Ciudad Autónoma de Buenos Aires. Zip Code C1429EBG.

<u>Describe Candidate's place of business</u>:

The Candidate's place of business is Mr. Antonio SAMPLE's own home, in a quiet neighborhood called "Saavedra." He has lived there for twenty years. The interview was held at a table in the spacious living room/dining room, on the first floor. The house has stairs on the outside, and when the door opens one enters into this living room/dining room. The space has two big windows, making it bright and light-filled. The ground floor, which our researcher was invited to visit later, is where the technicians work: the repair shop, or service shop. This latter consists of three large rooms, where three technicians repair electronic equipment.

The company has five staff members: one in charge of International Relationships and Translation (Lucila); three technicians (who do the electronic repair and service); and Antonio himself, who is proprietor and also an Engineer. Antonio and Lucila are also in charge of the commercial area. There are no shareholders.

Antonio and Lucila were very polite and nice to our researcher during the interview. Both of them, and the technicians, addressed one another and our researcher with respect and good manners. When our researcher visited the ground floor to have a look at the repair shop (because they suggested it), the technicians willingly showed our researcher around.

Interview Questions:

Ask Candidate the following questions and summarize answers provided:

a. Ask the Candidate about the technical ability of his/her Company to sell/service the client's products.

Antonio himself can cope financially, and he is the company guarantor. Besides, they have all the necessary equipment, including a Metrology Laboratory. This last is certified by the INTI (*Instituto Nacional de Tecnología Industrial*, that is: The National Institute of Industrial Technology, www.inti.gob.ar) and it deals with everything related to calibrations and equipment testing. They provide sales service, customer care and technical service.

b. Ask the Candidate if he/she has the training in an appropriate profession or if Candidate's employees have the right education/experience for the client's business, etc. The proprietor is an Engineer. The technicians are specialized in telecommunications, electronics, laser and radio frequency (all having graduated from the Technician High School). Lucila is a Sworn Certified Translator, in charge of International Relationships.

c. What market does Candidate believe the client has in the applicable country, and what are the value, scope and timing thereof?

He believes he can do business on behalf of the client's products with VENN SA, a company related to the government, a branch of the CONAE (*Comisión Nacional de Actividades Espaciales*, that is: the Space Activities National Commission, www.conae.gov.ar). It was established to produce and launch space rockets. It is a new company, and it has already made some tests. The rockets are meant to launch satellites in space, its payload being not heavier than 400 kgs. Antonio is already trading with this company. There could be plans to sell telemetry equipment, sensors, telecommunication equipment and (satellite) launcher controls (the rockets he mentioned above). The possibility of THE CLIENT selling these products to Venn will depend on the resolution of the needed Request for Proposal. If Antonio represents THE CLIENT, he will participate, in its name, in the request for proposal.

Globally speaking, he does customer care, consulting services, and technical assistance for many companies, and he could include THE CLIENT products in this business. Among these companies are:

- VENN, as mentioned.
- INVAP
- CONAE
- Fuerza Área Argentina (Argentine Air Force)
- Fábrica Argentina de Aviones (Argentina Plane Factory)
- INTI (Instituto Nacional de Tecnología Industrial, that is: Industrial Technology National Institute)
- CITEDEF (Instituto de Investigaciones Científicas y Técnicas para la Defensa, that is: Scientific and Technic Research for Defense Institute).

Though it is not possible to be precise, because there are many aspects to take into account, he can estimate the value of this probable market to be USD\$2-3 million regarding satellite products. Regarding rockets, the timing is up to four years, and the value is some figure between half a million and two million US dollars.

There is an extra advantage concerning marketing these products in Argentina: once a product is adopted by a company, it cannot be changed later for another brand.

There are also important possibilities of providing consulting services and technical assistance to Fabrica Argentina de Aviones, which is located in Córdoba.

In Argentina, it is strongly advised that foreign companies have a local representative, so that the local company has somebody visible to deal with, phone or ask for information when needed, etc., without any language barrier.

d. Ask the Candidate for additional customer and supplier references.

e. Ask the Candidate about upcoming business plans/upcoming changes.

It all depends on the economic situation of the country. There are no limits. If Argentina invests in business, his business will grow immensely. On the contrary, if there is an economic stand by, his business will suffer.

He used to be a representative of sample 2 before it was acquired by THE CLIENT, and, back then, their business was profitable. He would like to do business with sample 2 again. He says he is currently discussing this with Mr. Mitchell Sample from Sample 2 (referenced above).

f. Does the Candidate have a written code of conduct or policy on ethical behavior?

He does not have a code that is unique for everyone; he elaborates a confidential agreement ("Acuerdo de confidencialidad") with every customer or supplier, which is printed and signed by the two parties. This agreement is personal and therefore may differ from company to company because it is custom-made in every case.

g. Does the Candidate have a written policy or standards for business entertainment including gifts and customer travel?

He does not have a written policy on the matter, but he does have a policy. He says the only gifts his company makes is actually marketing material, given away on occasions such as Christmas and New Year's (rollerballs or pen drives with the company logo). Sometimes he takes a representative for dinner at a restaurant when he or she comes to Buenos Aires.

h. What are the spend limits of these policies or standards?

For taking a customer out, about 800 pesos each for dinner guest (which is a normal check not excessive- for an average good restaurant in Buenos Aires). For marketing materials, he doesn't recall figures but he says they are not significant.

i. Is the Candidate aware of the Foreign Corrupt Practices Act and that this law will apply to them as a Consultant/Distributor/Representative of a U.S. Corporation?

Yes. He has taken the courses on corruption, bribery and ITAR, at Sample 3, Philadelphia.

j. Has the Candidate provided any gifts or courtesies to any government official, including employees of government owned entities? If yes, please provide details.

No. Just electronic cards via e-mail for Christmas and New Year's Eve.

In the Fullcheck report his registered address is listed as being on Santa Fe Ave., and so our researcher asked him about that. He said that information is outdated, that he has not had that address for at least twenty years, and that he has lived in SAMPLE 3343 for the same amount of time. He added that his fiscal address was SAMPLE, Ciudad Autónoma de Buenos Aires. Apart from that, there were no gaps in information recognized by our researcher.

Conclusion/Recommendation:

q. Does the interviewer recommend Candidate as an International Consultant, Distributor, or Representative for the Corporation/Business Unit? If "No", please explain and outline any red flags here for review by the IAA.

Our researcher does not have any objections to the candidate. He gives the impression of being a straightforward and transparent person and our researcher did not find inconsistencies in what he said. Moreover, he constantly volunteered details and clarification to every question. Our researcher asked for permission to record the interview and he immediately agreed.

So, the answer is yes: based on this interview, our researcher recommends the candidate.
